Among other aspects, the FIBAA certification makes study courses internationally comparable and facilitates the recognition of course content and qualifications between universities. The MLP Corporate University (CU) is the first corporate university to achieve FIBAA certification.

The education programme offered by the CU thereby complies with the international requirements of the European Credit Transfer and Accumulation System (ECTS). Since the launch of the Bologna Process, the ECTS criteria have enabled students across Europe to more easily transfer to other universities based on recognition of their study courses and qualifications.
